

I am instructed by Fgura Local Council of 126/128, Kunsill Lokali il-Fgura, Triq Hompesch, Fgura, FGR2015 to submit its formal objection to application PC/00025/25, which proposes to identify and specifically delineate the zoning, square meterage and location for the planned supermarket development for the site located at Triq id-Dejma C/W Triq il-Parrocca C/W New Streets, Fgura. This formal objection is being tabled due to:

1. Insufficient Information on Project Density

The application fails to provide adequate details regarding the overall project density. While the proposed maximum building height of 17.5 metres is referenced, as interpreted from the Development Control Design Policy, Guidance and Standards 2015 (DC15), there is no clear indication of the number of floors or total gross floor area to be developed. This omission prevents a proper assessment of the project's scale, intensity, and its potential impact on the surrounding urban fabric.

2. Conflict with Strategic Planning Objectives

The proposed development is inconsistent with several objectives outlined in the Strategic Plan for the Environment and Development (SPED), specifically:

A. Urban Objectives:

- (i) UO 3.6 – Safeguarding the character and amenity of existing urban areas.
- (ii) UO 3.8 – Promoting sustainable urban development.
- (iii) UO 3.9 – Ensuring adequate provision of public open space.
- (iv) UO 4.2 & 4.3 – Managing urban expansion and ensuring compatibility with surrounding uses.

B. Thematic Objectives:

- (i) TO 9.6 – Promoting quality design and urban form.
- (ii) TO 9.7 – Enhancing the liveability and environmental quality of urban areas.

In light of the above, the Fgura Local Council formally requests to be registered as a third-party objector in relation to this application, in accordance with the relevant provisions of planning legislation.

We trust that the Planning Authority will give due consideration to the concerns raised herein and ensure that any development on this site aligns with the principles of sustainable and community-oriented urban planning.
