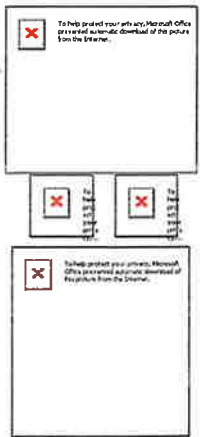

Kindly note that the visibility of logos and funding acknowledgements is not merely for promotional purposes. Given that approximately €20,000 is being funded by the Port Regional Council under the Region of Culture title and funding scheme, we are all bound to ensure that the logos of all funding mechanisms are clearly visible.

Failure to comply with these branding requirements may create difficulties for the Region in securing reimbursement under the Port Region of Culture funding mechanism from the DLG.

As a Region, our role is to verify that the branding is aligned with the specifications outlined in the Region of Culture Branding Manual. However, there is limited flexibility regarding the number of logos displayed. If these are removed, the Region would not be in a position to finance the event under this scheme.

Should the Council wish to proceed with the planning and implementation of the event while covering all financial aspects independently, it may do so and refrain from claiming funds under the Region of Culture funding mechanism.

Alternatively, you may consider requesting the supplier to provide a mock-up version of the token so that the logos can be adjusted accordingly. The four logos may be placed in banner format along the lower part of the design. In my opinion, any text placed beneath the logos should be removed, as it would likely be illegible.
