The Fgura local council hereby submits our objection to the proposed development in Fgura with ref to Pa 0650/24

The application fails to comply with the Development Control Design Policy, Guidance and Standards 2015 (DC15) in several key aspects. The massing, and site coverage are excessive and not in keeping with the surrounding streetscape. The development is likely to result in loss of privacy, overlooking, and overshadowing neighbouring properties, while also providing inadequate setbacks, parking, and waste management facilities. Furthermore, the proposal raises concerns regarding overdevelopment, poor design integration, and potential structural impacts due to excavation.

Additionally, there is a serious procedural issue. The plans approved by the Local Council together with the owner of the land in question differ from those submitted to the Planning Authority presently. As a result, the Local Council's feedback is no longer valid, and the consultation process has been compromised.

*Moreover, it is to be noted that in prior discussions between the Local Council and the rightful owner, it was clearly indicated that a **public open space** should form part of the proposed development. However, the plans submitted only provide space intended for the private use of residents within the development and do not constitute a publicly accessible space for the general community. This fails to meet the expectations previously established and does not contribute to the public realm.*

In view of the above, I respectfully request that the Planning Authority refuse the application or, alternatively, require that it be re-consulted with the Local Council based on the correct plans and in line with prior requirements regarding public space provision.

Essentially, I just removed the mention of the height as that is compliant with the local plans and DC 15.

I am writing on behalf of Mr Justin Bonnici, a resident of Fgura, further to previous correspondence dated 19 September 2025, to which no satisfactory action or resolution has been provided to date.

As previously reported, a tree located on Triq il-Kampanella, which falls under the responsibility of the Fgura Local Council, collapsed onto Mr Bonnici's vehicle, causing significant damage. A police report and photographic evidence were already submitted for your review.

Despite the time that has elapsed, this matter remains unresolved. In light of the Council's responsibility to ensure the proper maintenance and safety of public property, Mr Bonnici holds the Fgura Local Council fully liable for the damages incurred.

Without prejudice to all of Mr Bonnici's rights and remedies, we hereby formally request compensation for the full cost of repairs to the vehicle. Kindly confirm, within ten (10) days from the date of this letter, the procedure for settlement of this claim and the timeframe within which payment will be effected.

Should we not receive a satisfactory response within the stipulated period, Mr Bonnici reserves the right to proceed with further action to recover the damages without further notice.

Furthermore, we reiterate our concern regarding two additional trees on the same street which appear to be in a dangerous condition. Given the incident in question, the Council is urged to take immediate action to inspect and address these hazards to prevent further damage or potential injury.

We expect your urgent attention to this matter and look forward to your prompt reply.
